

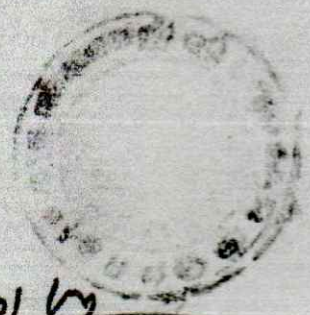

1. The name of the Trust shall be "SREE MAHARSHI EDUCATIONAL AND CHARITABLE TRUST" and its office shall be for the present at Sree Nilayam, Vellinezhi Post, Palakkad District - 679 504 and at such other place or places as the trustees herein may decide from time to time.

2. The object of the Trust are as under:-

(a) To develop, run and maintain institutions like schools, colleges etc., for the education of all boys and girls in all educative and vocational pursuits;

(b) To promote Vedas, Yoga techniques, Vedic culture and the like;

(c) To promote the medicinal system of Ayurveda and to found institutions for the research and treatment on this line.

(d) To develop, run and maintain other charitable institutions like hospitals, orphanages, old age homes and the like for the general public needy.

(e) To implement irrigation projects and to promote organic farming.

(f) To promote and work for environmental awareness and for world peace.

(g) To publish books and other articles on this line

(h) To donate to similar institutions having similar objects.

3. The number of trustees shall be not less than three and not more than five.

4. The present trustees are:


- (1) Sri. T.K. Vinayagopal, the founder mentioned above;

- (3) Sri T. Raveendranathan, s/o T.Kumaran, Thadathil House, Ezh umangad P.O Arangottukara;
- (4) Sri T. Krishnadas, Sreelakshmi, Manhakkad P.O. Shoranur.


5. The present trustees are life long members of the Board of Trustees.

6. In the event of resignation or death or removal of the present trustees, the Managing Trustee or after his death or resignation the other trustees shall have power to fill up the vacancy. The Managing Trustee shall have power to co-opt a new trustee.

7. The founder trustee T.K. Vinayagopal shall be the Managing Trustee.

8. The Managing Trustee shall have power to administer the funds of the Trust and any power exercisable by the Board of Trustees as may be delegated to the Managing Trustee.


9. The Trustees shall hold and stand possessed of the said amount of Rs.1,000/- (Rupees One Thousand only) hereinafter called the trust fund, which expression shall include the conversion thereof and/or the investment for the time being of the same and/or the investment or conversions of such accumulation, additions and accretions thereof and the dividends and/or income of the trust fund upon the trust and with and subject to the powers and provisions declared and contained concerning the same.

10. The investment of the trust fund for the interest or income thereof or any part thereof shall always be kept in the name of the Trust or of all or such number of trustees as may be decided by them.

11. The trustees may at any time sell, call in, convert into money, lease, demise, purchase and generally manage and deal with any property forming part of the trust fund and shall also have power to change or vary the investment according to law.

12. The trustees are hereby expressly authorised to accept gifts or donations of money or movable or immovable property from any person on such terms and conditions as may be deemed proper in their discretion.

13. The Managing Trustee shall hold office for life or until he resigns therefrom.

14. The Managing Trustee during his life time shall be entitled to nominate the successor Managing Trustee and in the absence of such nomination, the Board of Trustees may appoint the Managing Trustee on such terms and conditions as the Board of Trustees may deem fit.


15. The Managing Trustee shall have overall power of superintendence over the affairs of the Trust and shall have in particular, the power to open and operate the bank accounts, borrow moneys for the Trust and carry out the objects of the Trust.


16. Proper books of account shall be maintained by the trust and such account books of the trust shall be closed on 31st March of every year and got audited every year by a chartered accountant.

17. The trust fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.

18. The funds of the Trust shall not be applied for any purpose other than the object of the Trust stated in para 2 above.

19. The trustees shall have power to frame rules for the proper administration of the Trust, but such Rules shall not be against the objects of the Trust as in clause 2 above.


20. For the removal of doubts it is hereby declared that this Trust, its objects and its implementation shall not be for the benefit of any particular caste or religious community as such.

21. The Board of Trustees shall meet as often as may be necessary or convenient to transact business. The Board of Trustees might transact business and take decisions also by circulation of papers. Minutes of the meetings and all major transactions are to be recorded in the minutes book.

22. All decisions of the Board of Trustees shall be taken either unanimously or by majority. The quorum for a meeting is at least 3.

23. The Managing Trustee (Chairman) shall preside over the meeting of the trustees. He shall have a casting vote (besides his own) in the case of equality of votes among the trustees. In his absence the remaining trustees shall appoint anyone of them to function as Chairman of the said meeting.

24. The management and administration of the Trust shall vest in the Board of Trustees. Without prejudice to the powers of the Board of Trustees the Managing Trustee shall manage and administer the affairs of the Trust and shall also exercise such power and function as may be delegated to him by the Board of Trustees.

25. The funds of the Trust shall be invested in Bank Deposits, Government Bonds, or such other appropriate security as the Board of Trustees may decide. The surplus funds of the trust shall be invested in a manner conducive to the promotion of the objects of the trust and in accordance with and as provided for in Income-tax Act 1961 and subsequent amendments thereto from time to time.


26. The Trust Board shall have power to borrow monies for the purpose of the Trust.


27. Without prejudice to the generality of the provisions contained above, the Board of Trustees may also empower the Managing Trustee to represent or act for the Trust in any matter concerning the properties, funds, investments, borrowings and the making or cancellation of any instruments for any of these purposes.

28. The Managing Trustee may authorise any of the Trustees to act on his behalf and to operate bank accounts, etc.

29. The Trustees shall have power to appoint personnel to organise and promote the objects of the Trust and to regulate their conditions of service, including matters of discipline.

30. All acts and proceedings of the Trust shall be taken and conducted in the name of the Trust.

31. Any trustee may at any time resign his office by giving one month's notice to the Managing Trustee and upon the expiry of such period, such trustee shall be deemed to have vacated his office.

32. In case any of the trustees for the time being of these presents become bankrupt or insolvent or shall be convicted of a criminal offence involving moral turpitude or on account of any activity which is considered to be detrimental to the interest and/or object of the trust by the majority of the trustees, then and in every such case it shall be lawful for the other trustees to give notice to such trustee intimating that he is removed as trustee of these presents and thereupon such trustee of these presents, shall cease to be the trustee of these presents and such trustee and resigning trustee shall, after receipt of such notice and whenever called upon to do so, do all necessary acts on his part for vesting the trust fund and/or property forming part of the continuing trustee or trustees jointly with the new trustee to be appointed under the provisions contained in that behalf.

33. The Trust cannot carry ~~on~~ any business activity.

34. The Trustee shall not derive any benefit from the Trust.





35. The Managing Trustee shall have power to represent the trust in all matters. The Managing Trustee shall have power to execute all sorts of documents and deeds and get it registered by the concerned registry office. The Managing Trustee shall have power to appear before all Courts Offices of the Central and State Governments, Tribunals, Boards, Bodies, Local Bodies, institution or place; to sign and verify all sorts of pleadings, petition, application, affidavit, statement, declaration, return or other papers; to commence or defend proceedings; to confess, compromise or compound matters or claims; to conduct the proceedings till the end, obtain relief and realise the fruits; to remit or withdraw money; to apply for, inspect or take copies of documents or records; to accept service of order, summons, notice or other papers, to engage advocate, attorney, other practitioner or agent.

36. The Board of Trustees shall have power to take decision and frame such rules and regulations for fulfilment of the purpose of the trust and for carrying out of the object of the trust. The Board of Trustees also have power to make any amendment, alteration and addition to the deed of trust by a meeting of the trustees of not less than three members. However, no amendment to the trust deed shall be made which may prove to be



repugnant to the provisions of Sections 2 (15), 11, 12, 13 and 80G of the Incometax Act 1961 as amended from time to time. Further, no amendment shall be carried out without the prior approval of the Commissioner of Income tax or Director of Incometax (I.T. exemptions). The trustees shall have the power to do all such acts to effectuate the objects of the trust.

37. This trust is irrevocable.



38. 

WHEREAS the general body of the trust in their meeting held on 10th Day of February 2025 has unanimously resolved to amend the trust deed in the manner stated below and has authorized aforementioned present trustees to execute and sign the amendment deed and if required register the same.

The original Trust Deed contains 37 clauses. The trust intends to add/delete/ alter various clauses as amendment and this amended trust deed as final deed till any future amendment takes place. Following additional clauses to be added as an amendment.

38. **LOAN AND MORTGAGE CLAUSE:**


“Power to Borrow and Mortgage Trust Property”

The Trustees shall have the power to borrow money on behalf of the Trust from any bank or financial institution, with the authority to mortgage or charge the trust property, either in whole or in part, as security for the repayment of any loan or debt incurred. Such borrowing shall be for the benefit of the Trust and for purposes that align with the objectives and the powers granted under this Trust Deed.


The Managing Trustee is hereby authorized, in their absolute discretion, to execute all necessary documents and take all actions required to mortgage or pledge any of the trust assets as security for any loan, including the execution of a mortgage deed, charge agreement, or other related security documents, provided that:

1. **Loan Purpose:** The loan shall be used exclusively for purposes that directly benefit the Trust, including but not limited to investment in the Trust’s activities, operations, or assets, or for the fulfillment of the Trust’s objects as set out in this Deed.
2. **Terms of Loan:** The Trustees must ensure that the loan is obtained on terms that are reasonable and in the best interests of the Trust. The terms and conditions of any such loan, including the interest rate, repayment schedule, and any security required, shall be subject to the approval of the majority of the Trustees.



3. **Fiduciary Duty:** In taking any action under this clause, the Trustees shall exercise their fiduciary duties in good faith, with reasonable care, skill, and diligence, and in a manner that is consistent with the Trust's objectives.
4. **Notification to Beneficiaries:** The Trustees shall provide written notification to the beneficiaries of the Trust about any loan taken and the terms and conditions associated with such loan, except where confidentiality agreements prohibit such disclosure.
5. **Repayment of Loan:** The loan shall be repaid from the Trust's income or assets, as per the repayment terms agreed upon, and in a manner that does not compromise the primary objectives or the integrity of the Trust."

39. MODE OF UTILISATION OF FUNDS

- a) The assets entrusted to the Trustees by the Settlers above and/or any accretion to such assets shall be used to acquire or add any movable or immovable property, for the purpose of the Trust as may be decided by the board of Trustees.
- b) The incomes and assets of the trust shall be used only for charitable purposes herein stated and no part of the income shall be used or applied directly or indirectly for the benefit of any person referred to in Section 13(3) of the Income Tax Act, 1961 or any statutory amendment thereof.
- c) The funds received by the Trust at any time shall be used for the objects mentioned in this deed and the balance of unutilized funds shall be invested in accordance with the provisions of Section 11(5) read with Section 13 (1) (d) of the Income Tax Act, 1961 or such other sections or Act as decided by the Government from time to time.
- d) The Income and the funds of the Trust will solely be utilized for the objects of the Trust and no portion of it will be utilized for payment to the Trustees by way of dividends, profits, interests etc.

- e) The Trust corpus or any other accretion to it shall not be utilized for running any business for profits.
- f) At the time of acquiring any movable or immovable properties for the purpose of the Trust, the endowment funds collected and/or entrusted to Trust with direction that the income there from shall be used only for other specific purposes shall not be used for acquiring such properties.
- g) The Funds of the Trust shall be utilized for meeting the day-to-day expenses of the Trust including administrative expenses.
- h) No amendment to this deed shall be made without the prior approval of Commissioner of Income Tax
- i) If powers to effect amendment to the Trust Deed have been given the Trustees/ Office bearers, it would not be extended to altering the basic character of trust and further no such amendments which may prove to be repugnant to the provision of section 2(15), 11, 12, 13 and section 80 G of the income tax act shall be made
- j) The power of Board of Trustees shall be so exercised as to ensure that the income of the Trust would be extent under section 11 of the Income Tax Act 1961 as read with section 12, 12A amended from time to time. It is clarified that the investment of the trust funds including these mentioned in clause 6(iv) shall be exercised in accordance with the provision of sections 13 of the Income Tax Act 1961 in general and shall not violate the provisions of sections 12(1) (d) read with section 13(5) of the act to ensure exemption under the act,
- k) The trust will not function in conducting any business activity and not for the purpose of profits. In case trust intend to run any business, it will satisfy condition specified in section 11(4) and proviso to section 80 G (5) (1) of the income tax act 1961.
- l) The benefits of the trust are open to all irrespective of caste, creed, sex, religion etc.
